1. That vide Prima Facie Opinion dated 17th March, 2017 the Disciplinary Committee was of the opinion that **CA. Sukdeb Halder (M. No. 051185)** was prima facie **GUILTY** of Professional Misconduct falling within the meaning of Clauses (1) of Part II of the Second Schedule to the Chartered Accountants Act, 1949.

2. The aforesaid matter was pending for hearing before the Disciplinary Committee under Rule 18 (6) of the Chartered Accountants (Procedure of Investigation of Professional and Other Misconduct and Conduct of Cases) Rules, 2007.

3. In the meantime, an e-mail dated 04th January, 2019 was received from Kolkata office wherein the demise of the Respondent, CA. Sukhdeb Halder on **26.06.2017** was intimated. Copy of death certificate along with forwarding letter submitted by his son Shri Sudip Halder as received from Kolkata office were taken on record by the Committee.
