1. That vide report dated 07<sup>th</sup> November, 2017 the Disciplinary Committee was of the opinion that **CA. Chinmoy Ghatak (M.No.003591)** was prima facie **GUILTY** of Professional Misconduct falling within the meaning of Clauses (2), (7) and (8) of Part I of the Second Schedule to the Chartered Accountants Act, 1949.
2. Subsequently, an email dated 26<sup>th</sup> July, 2018 was received from Respondent's son Shri Deba Pratim Ghatak informing of the demise of the Respondent CA. Chinmoy Ghatak on 22<sup>nd</sup> March, 2018 due to heart attack. Copy of death certificate along with his letter were taken on record by the Committee.
3. The Committee noted that due to death of the Respondent, the matter became infructuous and accordingly the proceedings were abated.


