#### ORDER

- 1. The bench is convened through video conferencing.
- 2. Heard the Learned Counsel for the parties and perused the record.
- 3. This appeal has arisen out of the Impugned Order dated 07.02.2024 (Findings) passed by the Disciplinary Committee, The Institute of Chartered Accountants of India whereby the Appellant was held 'Guilty' of Professional Misconduct falling within the meaning of

Clauses (5), (6) & (7) of Part I of the Second Schedule to the Chartered Accountants Act, 1949 and consequential Order dated 11.07.2024 awarding him a punishment of removal of his name from the Register of Members for a period of One year which shall run concurrently with the punishment awarded in the disciplinary case no. PR/255/2013-DD/251/2013-DC/675/2017.

- 4. Today is the first date of hearing in the matter.
- 5. At the very outset, the Learned Counsel for the Appellant submitted that due to the fact that the Appellate Authority was not duly constituted when the Impugned Orders dated 07.02.2024 and 11.07.2024 were passed by the Respondent No. 1, the Appellant had approached the Hon'ble High Court of Delhi, vide W.P. (C) 9545 of 2024, for seeking stay against the operation of the punishment Order dated 11.07.2024. The Learned Counsel for the Appellant has further submitted that the Hon'ble High Court of Delhi, on 15.07.2024, has inter alia passed the following Order:
  - "6. In view of the foregoing, it is directed that till the preliminary hearing of the appeal (propose to be filed), the Impugned Orders, being the penalty order dated 11<sup>th</sup> July, 2024 and the findings order dated 7<sup>th</sup> February, 2024, shall be kept in abeyance.
  - 7. Consequently, Respondents are directed not to issue a gazette notification in terms of the aforenoted Impugned orders till the preliminary hearing of the said appeal, to be filed by the Petitioners."
- 6. Issue notice to the Respondents. The Ld. Counsel for Respondent No. 1-3 accepts notice. None appeared on behalf of Respondent No. 4. The Registry is directed to serve the notice upon Respondent No. 4 along with the copy of this Order. The copies of the Appeal have already been supplied to the Respondents.
- 7. The Learned Counsel for Respondent No. 1-3 sought time to file reply to the Appeal. As prayed, Respondents are granted four weeks' time to file reply to the Appeal. The Appellant will have,

thereafter, four weeks for filing rejoinders thereto, if any. The parties are directed to exchange the pleadings.

- 8. In the meantime, the impugned punishment Order dated 11.07.2024 shall be kept in abeyance till the pendency of this Appeal
- 9. The Registry is directed to allot regular number to this Appeal and list the matter after the expiry of the aforesaid period.
